They individually said that they were in support of the request. Chairman Bridges asked if anyone else was in favor of the request from Van Tran. There was no one else to speak in favor of the request from Van Tran. Chairman Bridges asked if there was any opposition to the Van Tran request. There was no opposition to the request.

Chairman Bridges stated that the public hearing will remain open until the remainder of the 30 minute period to allow for additional comments or concerns from the citizens of the

County. He also stated that these items will be voted on at the regular board meeting following the public hearing. There were no further comments or concerns from anyone. The meeting adjourned at 5:59 p.m.
